Prevention of Sexual Harassment and Abusive Conduct Training for Managers and Employees

FRESNO: Tuesday, September 15, 2020
2nd Date To Be Announced

California Law Requirements:
An employer with 5 or more employees

- Provide sexual harassment training and education by January 1, 2021 (not January 1, 2020), and thereafter once every 2 years.
- New nonsupervisory employees be provided sexual harassment training within 6 months of hire.
- New supervisory employees be provided sexual harassment training within 6 months of the assumption of a supervisory position.

It clarifies that an employer who has provided this training and education in 2019 is not required to provide it again until 2 years thereafter.
